



Canada Winter Games 2027 – Saskatchewan Alpine Ski Team

Candidate Nomination Form

1. Purpose

This form is to be completed by a Saskatchewan Alpine club coach together with the nominated athlete and parent/guardian to declare the athlete's intent to participate in the 2027 Canada Winter Games (CWG) Selection & Training Process, including mandatory camps and selection events, and to request candidacy for Saskatchewan Alpine resource support.

Submission of this form indicates the athlete wishes to be considered for CWG preparation programming. Nomination does not guarantee selection to the CWG team.

2. Key Considerations

The club coach is expected to ensure their nominee understands and intends to meet the following considerations:

- The athlete meets eligibility requirements specified in the Saskatchewan Alpine CWG 2027 Selection & Training Policy and the 2027 CWG Technical Package.
- The athlete understands selection is based on performance, fitness, and professionalism, and that Saskatchewan Alpine reserves the right not to fill all quota positions if minimum standards are not met.
- The athlete intends to apply themselves to an appropriate conditioning and skills development program to prepare for CWG-level competition.
- The athlete understands participation in mandatory camps and selection activities is required unless an exemption is requested and approved in writing in advance.

3. Nominee Submission and Candidate Selection

Details for submission and selection are described in the Saskatchewan Alpine CWG 2027 Selection & Training Policy available on the Saskatchewan Alpine website.

Key submission requirements include:

- Signed nominations must be sent to the Saskatchewan Alpine Head Coach at: coach@saskalpine.com
- Nomination and application deadline: **March 1, 2026**
- Candidate status and access to resource support will be determined through Saskatchewan Alpine's CWG selection process.



4. Resource Access

Nomination at this stage is intended to identify athletes who may be eligible for Saskatchewan Alpine support resources (such as training opportunities, coaching access, dryland support, and/or funding) as available.

Resource access may be dependent on the athlete demonstrating compliance with Saskatchewan Alpine program expectations, including attendance, effort, and commitment.

Some resources may also be available to athletes outside the nominated candidate group. Resource support does not guarantee team selection.

5. Important Dates and Information

1. Athletes must complete this nomination form with their Parent/Guardian.
2. A letter of recommendation must be provided by the Head Coach of the athlete's club.
3. Athletes must attend mandatory CWG camps, fitness tests, and selection activities as outlined in the Saskatchewan Alpine CWG 2027 Selection & Training Policy, unless an exemption is requested and approved in writing.
4. Athletes will be evaluated using the published selection criteria and weighting system outlined in the Saskatchewan Alpine CWG 2027 Selection & Training Policy, including competitive performance, fitness testing results, and coachability/professionalism.
5. Athletes must be prepared to compete in the events for which they are eligible and selected, as defined in the CWG Technical Package (Able-bodied: SL/GS/SG/SX; Para-Alpine: SL/GS).
